# **DOSAGE**

Recommended dosage range 0.5 – 5.0 mass-% of the cement content;

is equivalent to 1.6 - 16 g per kg cement.

Overdosage can lead to very strong expansion, reduced strengths, and high porosity and must be avoided.

#### **WORKING PRINCIPLE**

The calcium oxide contained in DURAHIT® Expand-10 hydrogenates to calcium hydroxide and thus achieves an expansion effect. This chemical prestressing counteracts shrinkage.
